Avoid dispersal of dust in the air (i.e, clearing dust surface with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.

8.2 Exposure controls

Appropriate engineering controls

Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
