Lab Alley hereby declares that the above mentioned product and the raw materials used in the manufacturing process, plant facilities including packaging, warehousing and shipping is free from allergens including but not limited to list below.

- 1. Peanuts, peanut oil and derivatives
- 2. Tree nuts and derivatives almonds, Brazil nuts, cashews, chestnuts, pine nuts, pistachio, macadamia, walnuts, hazelnuts/filberts, pecans, etc.
- 3. Fruits, vegetables and derivatives
- 4. Seeds and derivatives (including oils, paste, etc.) cotton, poppy, sesame, etc.
- 5. Legumes beans, soybean & all soy products, tofu, peas, lupin, guar gum, etc.
- 6. Animal origin and derivatives beef, chicken, poultry, pork & derivatives
- 7. HAP (Hydrolyzed Animal Protein)
- 8. Milk and dairy products includes butter, buttermilk, whey, lactose, cheese, casein, cream, curds, sodium caseinate, etc.
- 9. Egg and egg products liquid and powders, etc.
- 10. Fish and derivatives fresh and ocean water fish, surimi, fish bases, oil, etc.
- 11. Shellfish and crustaceans (shrimp, prawns, crab, lobster, crayfish, etc.)
- 12. Cereal and Cereal products (including barley, oats, bran, starch, flour, etc.)
- 13. Wheat (flour, bran, gluten, starch, farina, graham flour, semolina, etc.)
- 14. Gluten (wheat, oat, rye, barley, millet, triticale, spelt)

- 20. Unrefined Oils (soy, corn, tree nut, cottonseed)
- 21. BHA / BHT / TBHQ & other Antioxidants
- 22. Tartazine / Artificial Coloring (including FD&C Yellow 5 & 6, Blue 1, etc.)
- 23. Celery Roots & Extracts (stem, leaf, seed)
- 24. Corn (meal, bran, flour, dextrose, starch, etc.)
- 25. HVP (Hydrolyzed Vegetable Protein)
- 26. Mollusks (mussel, clam, oyster, scallop, snail, abalone, squid, etc.
- 27. Sulfites includes sulfur dioxide, chemicals that list sulfite, and often in shrimp, wine, potatoes, etc. Naturally occurring or added
