## SECTION 4: First aid measures

### 4.1 Description of first-aid measures

#### General advice

<b>If inhaled</b>	Remove to fresh air. If not breathing, give artificial respiration. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
